### **Declare in general:**



- to be familiar with the scope and contents of international security regulations on ships and port facilities (International Ship and Port facility Security code – ISPS Code);
- to be aware for ocean shipping and port facilities to be secured in accordance with the ISPS-Code;
- to be willing to apply security to services rendered or goods delivered to such a further specified level that the safety of ocean-going vessel and the port facility will not be affected adversely ;

### **and declare in particular:**

- that the goods supplied have been packed and loaded under controlled circumstances guaranteeing that no unauthorised persons have any access during or after packing, loading or carriage;

- that packaging, loading and carriage is carried out exclusively either by employees of the company mentioned above or of hired companies or persons, in which case employees of port facility and/or ocean-going vessel have been informed in time prior to delivery;
- that the goods are delivered in accordance with all relevant national and international regulations and accompanied by all documents and certificates required and applicable;
- that the employees delivering the goods observe the security regulations of the port facility's and/or ocean-going vessels as well as the instructions by the port facility's employees and the ocean-going vessels crew;
- that the persons delivering the goods remove any material left after delivery, such as boxes, pallets and packaging materials.
