- * that packaging, loading and carriage is carried out exclusively either by employees of the company mentioned above or of hired companies or persons, in which case employees of port facility and/or ocean-going vessel have been informed in time prior to delivery;
- * that the goods are delivered in accordance with all relevant national and international regulations and accompanied by all documents and certificates required when applicable;
- * that the employees delivering the goods observe the security regulations of the port facility and/or ocean-going vessels as well as the instructions by the port facility's employees and the ocean-going vessel's crew;
- * that the persons delivering the goods remove any material left after delivery, such as boxes, pallets and packaging materials;
